Please send compliance report through affidavit within a period of 03(Three) months to the University from the date of issue of this letter.
- 4. The University may inspect the College at any working day without information to check the infrastructure and other academic activities of the College as per guidelines of GoB/BEU.
- 5. All minutes of Governing Body of the College should be submitted to the office of the Bihar Engineering University, Patna at the earliest.
- 6. When any vacant posts will be filled by the College, University representation should be invited. Any appointments must be done in the presence of University Representative.
- 7. College is requested to approve and appoint all teaching & non-teaching employees as per guidelines of the AICTE in three months.
- 8. The provisional affiliation has been granted in anticipation of approval of the Executive Council, Bihar Engineering University, Patna.
